The Conservatorship Association of Tennessee (CAT) is a membership organization of people who are concerned about the quality of services for the increasing number of vulnerable Tennesseans who need assistance in decision-making. Membership is open to conservators, guardians, attorneys, representative payees, advocates, family members, judges, magistrates, physicians, social workers, case managers and anyone else interested in improving the lives of Tennesseans who may need conservatorship or guardianship services.

CAT is a non-profit organization whose goal is to promote a nationally recognized standard of excellence in conservatorship and guardianship consistent with Tennessee laws and practices.

CAT is an affiliate of the National Guardianship Association.

Membership is available to anyone interested in improving conservatorship practices in the categories below:

CHECK ONE

Individual/Professional Membership (\$75.00) is open to those who serve as professional conservators/guardians, as well as those who support conservatorship and guardianship in related fields of healthcare, social work and other professional services.

Organizational Membership (\$150.00) For groups/agencies who wish to enroll multiple individuals from the same for-profit business, government agency, court system, non-profit agency, etc. Membership in this category applies to organizations that provide professional conservatorship and guardianship services, as well as to those that offer related services that support conservatorships and guardianships. **Annual dues of \$150.00 provide a listing for one person the organization identifies as their primary contact. Other individuals may then be ADDED as members from the same organization for an ADDITIONAL \$50.00 per person.** All benefits of membership are available to each individual who is identified as a member by the organization.

Court Judges and Clerks; Family/Volunteer/Retired Membership (\$25.00) is open to Court Judges and Clerks; family members who serve as conservators and guardians; individuals working as conservators and guardians without remuneration; those who are retired from providing professional conservatorship and guardianship services and consumers and advocates interested in supporting the goal of CAT.
